

















#### Dear Mr./Ms.:

- 1. City Investments To Innovate, Integrate and Sustain (CITIIS) 2.0, the second phase of the CITIIS program, has been conceived by MoHUA in collaboration with Agence Française de Développement (AFD), Kreditanstalt für Wiederaufbau (KfW), European Union (EU), and National Institute of Urban Affairs (NIUA) to supplement such climate initiatives of Government of India and MoHUA through its unique model. The program builds upon the learnings and successes of CITIIS 1.0 and is designed to supplement MoHUA's actions undertaken through ongoing national programs, while deepening the values of innovation, inclusion, and sustainability.
- 2. The National Institute of Urban Affairs (NIUA) (hereinafter called "Client") has been designated as the Program Management Unit (PMU) by the MoHUA, AFD and KfW towards managing the CITIIS 2.0 program. The Client intends to apply a portion of the funds to eligible payments under the contract for which this Expression of Interest (EOI) is issued for selection of a Consultant / Individual Expert. The duration of the services is expected to extend up to 48 months depending upon the nature of the projects.
- 3. International Mentors (Individual Experts/Consultants) with successful and high standard of achievements and proven experiences are invited to submit their EOIs as per the submission format annexed to this document.
- 4. Among the submitted applications, the CITIIS PMU will shortlist upto 10 International Mentors based on Quality of proposals (QBS). Only shortlisted bidders will be issued Request for Proposal (RFP) Documents, including Terms of Reference (TOR) for the assignment, and be invited to submit a detailed proposal. CITIIS-PMU expects to appoint upto 4 International Mentors in this bidding process. Eligibility criteria to AFD financing are specified in sub-clause 1.3 of the "Guidelines for the Procurement of the AFD-Financed Contracts in Foreign Countries" available online at www.afd.fr. Candidates are required to submit the "COVENANT OF INTEGRITY" as per the format provided as a part of their EOI.
- 5. International Mentors having contractual obligations with the current employer to submit an EOI on individual basis, would have to submit an undertaking with endorsement from the current employer as per the submission format provided in **Tech Form 3**. Undertaking has to be cosigned by the head of the institution/organizing for consideration of EOI evaluation.
- 6. The EOI shall be published on the NIUA website and e-published on CPPP and is free for download. Bid Security / Earnest Money Deposit (EMD) is not required for the submission of the proposal. It is not permissible to transfer this invitation to any other Individual Expert/Consultant.

#### Terms of Reference

#### **Background**

CITIIS 2.0 is a program conceived by the Ministry of Housing and Urban Affairs (MoHUA) in partnership with the French Development Agency (AFD), Kreditanstalt für Wiederaufbau (KfW), the European Union (EU), and National Institute of Urban Affairs (NIUA). The program envisages to support competitively selected projects promoting circular economy with focus on integrated waste management at the city level, climate-oriented reform actions at the State level, and institutional strengthening and knowledge dissemination at the National level. The funding for CITIIS 2.0 would include a loan of Rs.1760 crore (EUR 200 million) from AFD and KfW (EUR 100 million each) and a technical assistance grant of Rs.106 cr. (EUR 12 million) from the EU.


#### **Objectives of CITIIS 2.0**

- i. Foster climate-sensitive planning and action The program will nurture climate planning and action in States and cities through evidence-driven approaches.
- ii. Drive investments into urban climate action The program will provide financial assistance for competitively selected projects promoting circular economy with focus on integrated waste management.
- iii. Build institutional mechanisms, leverage partnerships and anchor capacity building The program will help put into place a climate governance framework at the State and City levels as well as provide a three-tier technical assistance structure with domestic, international, and transversal experts to support capacity development for climate action in cities and States.

#### CITIIS 2.0 has 3 components

- i. **Component 1**: City Level Action on Promoting Circular Economy with Focus on Integrated Waste Management
- ii. **Component 2**: State-Level Action on Strengthening Climate Governance Mechanisms for Climate Action Through Data-Driven Planning & Capacity Building
- iii. **Component 3**: National-Level Action on Institutional Strengthening, Climate Research, Knowledge Capitalisation and Capacity Building

#### **Component 1**



#### Coverage of the Program

The CITIIS grant amount for each project under Component 1 will be limited to 80% of the total project cost, up to INR 135 Crore (90% of the total project cost, in the case of North-Eastern and Hill States). The additional funds, i.e., 20% of the total project cost will be mobilised by the selected city through own source funding by the State/ Local Governments (10% of the total project cost, in case of North-Eastern and Hill States).

Following 18 cities have been selected by MoHUA under CITIIS 2.0 through challenge process - Agartala, Agra, Bareilly, Belagavi, Bilaspur, Guwahati, Jabalpur, Jaipur, Madurai, Muzaffarpur, New Town Kolkata, Panaji, Rajkot, Srinagar, Thanjavur, Thiruvananthapuram, Udaipur and Ujjain

Each project will now go through 2 phases – Maturation Phase and Implementation Phase.

Maturation Phase (up to 12 months)

Subsequent to the selection, each city shall undergo the maturation phase. During the maturation phase, the SPV/ULB will be required to refine and de-risk their project components through technical assistance provided by the Domestic experts.


Implementation Phase (up to 30 months)

After the validation of the Maturation Phase deliverables by the Apex Committee, the Implementation Phase will start. The procurement process will be launched in this phase and cities will proceed to the implementation of the projects. In addition, biannual progress reports and E&S documents/progress and monitoring reports will be developed and submitted to the PMU. During the Implementation Phase, SPVs/ULBs will continue to benefit from the Domestic Experts' support.

#### **Component 2**

Component 2 of the CITIIS 2.0 program envisages strengthening climate governance mechanisms for climate action through data-driven planning and capacity building. Under Component 2, INR 264 crore (EUR 30 million) have been allocated to support States & Union Territories with climate action. The support will be provided in the form of a financial and technical assistance grant from the Government of India. The awarded grant will be utilised to assist States in strengthening existing climate governance mechanisms for climate action through:

- Setting up/strengthening existing State Climate Centres/Climate Cells/ equivalent departments;
- Creating State and City-level Climate Data Observatories;
- Facilitating data-driven planning and implementation of climate action plans. The plan shall lay special emphasis on solid waste management, wastewater management and water security through integration with the master plans of the cities. The plan shall take into consideration the estimated need for water, its current availability, future projections, and subsequent measures to ensure the water balance is maintained;
- Building the capacities of municipal functionaries through programs such as Leadership in Climate Change Management (LCCM).



Overview of Component 2

CITIIS 2.0 Guidelines for State Action (Component 2) are attached separately on the https://niua.in/tenders page for "Consultancy Services for Technical Assistance under CITIIS 2.0 Program – International Mentors" and can be downloaded from there.

#### **Component 3**

The National-level component aims at the institutional development of NIUA and capacity building at all three levels (Central, State and Local) to further climate governance in urban India. The knowledge, research, templates, and best practices developed through the program shall be made available to all ULBs in India, thus positively contributing to India's Nationally Determined Contributions (NDCs), and commitments made at COP26 and COP27. It also aims at optimizing and strengthening national-level actions through five main subcomponents:

- Technical assistance through a mentorship model
- Monitoring and evaluation
- Technology integration
- Knowledge capitalization
- · Communications and outreach

International Mentors will provide guidance and coaching to the States under Component 2 and to the PMU for capacity building activities under Component 3.

#### A. Scope of Inetrnational Mentors

The scope of intervention for International Mentors will include (but not be limited to):

- Guiding the States towards the fulfilment of program objectives and interventions under Component 2
- On a case-by-case basis, providing technical recommendations by bringing in International expertise and best practices/use case studies

- Conducting capacity-building workshops for the States/at the National level in relation to cross-cutting/transversal topics through their design, facilitation and conduct
- Supporting the knowledge capitalisation process and assisting the PMU in the knowledge management process as follows -
- ✓ Identification of innovative/outstanding practices and relevant information and knowledge in the area of climate change
- ✓ Documentation and collection of information to enable the identified material to be described and illustrated using a variety of sources

#### B. Duration of consulting services

It is envisaged that the duration of consulting services will be for 5 days each month for a period of 48 months and bi-annual missions will be required each year (i.e. 8 international trips during 4 years).
