B. UPYOG Training/ UPYOG Certifications

In order to create an ecosystem of UPYOG trained professionals, the NUDM offers eLearning courses through NULP Platform and also conducts offline training sessions for periodically. The empanelled agencies agency nominate empanelled should professionals for online and offline training and ensure that at least 10 technical professionals are trained on UPYOG through these training sessions.

Review of the empanelled Agencies

This review of empanelled agencies will be done by the committee annually & whosoever not meeting the continuation parameters shall be considered for dis-empanelment after approval from the competent authority.

Note – The dis-empanelled agencies may request for the re-empanelment post six months of the dis-empanelment under NUDM.
